Your kindergarten has been added to the IASWECE World List and to the World Waldorf List of Schools and Kindergartens published by the Pedagogical Section, the Friends of Waldorf Education and IASWECE. Please check the contact information on the world list at [www.iaswece.org/world-list/](http://www.iaswece.org/world-list/) and notify us of any changes.

This recognition and listing will be for a period of five years until January 2029. It will then need to be renewed before the listing can continue. IASWECE has the right to terminate the recognition at any time.

If during this five-year period a Waldorf Association in your country becomes an IASWECE Country Member, then IASWECE recognition of kindergartens in your country will take place through your country association and no longer directly by IASWECE. To continue to be recognized by IASWECE, your kindergarten would need to apply for and receive recognition by the IASWECE Member country association.

Recognition by IASWECE does not include official permission to use the names "Rudolf Steiner" and "Waldorf". Permission for name use is given by the Licensing Body of the International Forum for Steiner/Waldorf Education in collaboration with IASWECE. Please contact IASWECE if you have questions.
